

Hello Marion/Polk OSWA members, we have 3 events planned in March, April and May.

First, Taylor Kittell from Breakwater Law, will give her excellent presentation on "**Estate Planning for Woodland Owners**", that will include information on SB 498, which passed in the 2023 Oregon legislative session. SB 498 raises the estate Natural Resource Credit from \$1 million to \$15 million-this will have huge implications for many woodland and farm owners.

Next, will be a tour discussing and showing which trees would likely be cut in a **pre-commercial thinning**, **and in a commercial thinning operation**. We will look at areas where pre-commercial and commercial thinning have recently been completed. Discussion will be focused on tree selection criteria, methods and machines used and the reasons for thinning. We might even stop at some of our Coast Redwood stands! There will be ample time to answer any questions you may have. Some walking in the woods will be necessary so dress accordingly.

Included will be a discussion on site prep and herbicide application after seedlings are planted.
